1) Portfolio:

- Motivation Letter
- Essay
- Results of educational activities
- Results of professional, scientific and research activities
- 2) Interview

Suggested essay topics:

- 1. International Human Rights Law and the UN Sustainable Development Goals.
- 2. Human Rights and Climate Change.
- 3. The death penalty, life imprisonment and human rights: problems of correlation.
- 4. The role of lawyers in the implementation of human rights.
- 5. Human rights and their impact on domestic and international peace, security and development.
- 6. Own topic related to areas of research and/or objects of professional activity and the title of this master's program.
